

ENTREPRENEUR BONUS 2023 OF \$ 2000 USD FOR ENTREPRENEURS LIFE PLATINUM

POINTS PLAN

- 1. The conditions contained in this document will be applicable from cycle 02/2023 (February 1, 2023) until cycle 12/2023 (December 31, 2023). The entrepreneur will be able to start participating in any of the cycles of validity, **once the correct registration has been made**.
- 2. During a single cycle the entrepreneur must earn at least 500 total points, where 200 points must be from personal purchases and 300 points from Non Life network that do not depend on a Life entrepreneur, make 07 first purchases from new entrepreneurs and have 4 Life entrepreneurs from their first line achieve the Life Platinum title in a single cycle.

Clarification: It is important to clarify that the entrepreneurs to be recognized with the title of Life Platinum must be at 40% in the cycle prior to the cycle of participation in the present incentive; and that in the same cycle of participation in the bonus must be to become Life Platinum entrepreneurs.(Remember that to become platinum entrepreneurs in a single cycle you must make 400 personal in a single cycle or 300 Non-Life network points that do not depend on a Life entrepreneur and 200 personal points in a single cycle).
